- Tim stated that there are talks of Lake Wequaquet not allowing anglers to park their vehicles along the road police will ticket them
 - o Time is looking into it to see of this is valid or just rumors

Old Business:

- Joe McKinnon stated that TH Marine has sponsored Mass Bass with a 40% discount off of their products. Take a look at their website and let Joe know what you are looking for and he will place an order. Joe will be periodically placing orders throughout the year and will consolidated each individual order into larger group orders
- BASS is making the move to enforce that all cull tags used in their tournaments be nonpiercing. Joe McKinnon received a call from and angler asking if FLW was going to do the
 same. Joe talked to Robert and he said at this time TBF & FLW are not switching over to that
 requirement because there is no scientific data showing that the holes in the fish is coming
 from cull tags and not from crawfish claws or fish spines (or that the lips do not heal). TBF &
 FLW have talked to biologists and they have discussed it internally and decided that at this
 time they are not enforcing this rule.
- Youth T-shirt fundraiser
 - o There is a 3 day turnover for orders
 - We have to buy in gross quantities the more we buy the cheaper the cost
 - There will be one order placed in the next two weeks so Directors need to gather your orders of sizes & quantities and email Joe asap
 - They only come in Ash / gray color as shown in the picture
 - Cost is \$15 per shirt
 - See below for sample of what shirt will look like
 - Sizes will be M, L, XL, 2X, 3X,4X. Only 1 dozen each of 3x and 4x will be ordered
