Fizzing is a common method for helping bass with barotrauma return to depth. The problem is that when bass are fizzed, in 60+% of the cases we observed they go straight to the bottom. If fish are released in 20 or 30 feet, that is not a problem. However, if fish are released over deep water (say 75feet), they will likely end up in that depth which may exceed their abilities to survive. We found that even a puncture (rather than full fizzing) led to fish being unable to avoid going to the bottom so it is not a matter of overfizzing being the problem. So - the take home message is to release bass over bottom habitats where you would catch bass and with a maximum depth of ~30 feet. This is important info for tournament organizers and anglers.
